Pursuant to a FOIA request Gregory Tony has mailed out brochures and information cards with his pictures and name on them to 62,090 voters. He printed **225,000** brochures and information cards and holiday cards, if he mailed each of the Brochures and cards to the **62,090 voters** on his mailing list he would spend approximately **\$80,000 per mailing in postage**. To print the brochures, he spent over **\$115,387.00** to date.

The Sheriff Tony Initiatives 6-page booklet that he hands out at all his events costs **\$16,487.00** for a printing of **50,000 copies**. The booklet contains numerous misleading and false information that Toy has to know are false as indicated below:

False statement #1 – Page #1 – As the Sheriff of Broward County and an expert in training for active shooter and mass casualty events” (Tony is a self-proclaimed expert in active shooter, he is listed in no publication, no entity other than Blue Spear Web Site as an expert, he says he trained 25,000 people around the country, and numerous law enforcement agencies, and developed Active Shooter platforms for these agencies around the country – I bet he can’t name 10 agencies he trained)

False Statement #2 – Page #2 – We have acquired a 2.2-million-dollar grant for expansion of the guardian program, an integral component of school safety and security in Broward County.” (Tony asked for the 2.2 million not to expand the program but to buy stop the bleed kits, he put a bid out, the bid was awarded to his former employer North American Rescue then he received two PAC donations from the CEO and then the CFO of North American Rescue)

False Statement #3 – Page 3 – BSO has the most diverse command staff in BSO’s 104-year history. (Another self-proclaimed accomplishment both Scott Israel and Gregory Tony had 13 members on their respective command staffs, Sheriff Israel had 11 minorities on his staff that had 309 years of institutional knowledge and Sheriff Tony has 9 minorities on his command staff that have 288 years of institutional knowledge)

False Statement #4 – Page 3 – The first female colonel and the first two Cuban colonels’ American colonels have been appointed making agency history. (1 of the two colonels he is referring to, James Reyes was promoted to that rank by Sheriff Israel)

False Statement #5 – Page 4 – Signed training agreements with the Department of Homeland Security, the Federal Bureau of Investigation and the Federal Emergency Management Agency to certify BSO instructors (This is a misleading statement as any law enforcement agency can send as many people as they want to the Federal Sponsored Active Shooter Schools, its not a contract it’s a matter of signing up to attend a 3 or 4 day class to get certified. The fact that he trained every single 25 instructors in active shooter is something anyone could have done, however, most agencies only send a few instructors to those schools because there are a lot more issues police officers have to be trained in other than active shooter. He added 13 trainers to the 12 Sheriff Israel had, all 13 were SWAT officers that he took off the road, leaving the road without an on-duty SWAT response team. Further the 13 SWAT officers added to the training staff are tactical trainers, like I said before there are a lot of other training that needs to be done other than Active Shooter just for a political statement.)

False Statement #6 – Page 4 – Reallocated 1 million to add additional 25 full-time deputies to the training bureau. (This is a false statement as 12 of the 25 were already at the training bureau, so he added 13 officers, they were not promoted, they did not get a pat raise, so

it is reasonable to believe that he did not have to spend 1 million dollars to transfer them to another unit.)

False Statement #7 – Page 4 – Expected to break ground on the training center in December 2019 (Hence the bogus groundbreaking ceremony)

After BSO complied with the Public Records Request providing the above information, several more fliers and even a newspaper type publication began to appear in residents mailboxes all around Broward County, in one of the cards / flier depicted below, it portrays the pictures of all the command staffers and on it says how diverse they are. Now even though the flier is full of misrepresentations, the only way they can use the BSO budget, it to couch the flier as a recruitment flier, so on the last line of the flier is says "come and join us." Obviously the flier has no public safety message and like others are clearly for name and face recognition of Gregory Tony. Further they flier was sent to residents all over Broward County, including Century Villiage residents, not sure if those are a targeted group of people to recruit as deputies.
